Hearing Agenda

- c. Board Staff will be allotted up to one hour to present its response to the positions set forth by the City and the District.
- d. The District will present its rebuttal, if any.
- e. The City will present its rebuttal, if any.
- f. Board Staff will be allotted up to 30 minutes to present its response to the rebuttal positions set forth by the City and the District.
